Each such invoice or other agreement, and the terms and provisions thereof, shall be governed in all respects by, and interpreted and enforced in accordance with, the laws of the State of Wisconsin (without giving effect to its choice of law rules.) Applicant understands and agrees that Price Engineering may disclose any portion of this application (A) in connection with or during any action, proceeding, or undertaking by Price Engineering or its agents, successors, or assigns to enforce or seek compliance of Applicant with the Terms and Conditions stated herein or in any invoice or other agreements with Price Engineering or (b) to the extent Price Engineering reasonably believes such disclosure is required by applicable law, court order or other legal process.
